Note 1: Sadlerochit Petroleum is any petroleum delivered to Carrier from the Sadlerochit Formation in the Prudhoe Bay Unit. Lisburne Petroleum is any petroleum delivered to Carrier from the Lisburne Formation in the Prudhoe Bay Unit. Kuparuk Petroleum is any petroleum delivered to Carrier from the Kuparuk Pipeline. Endicott Petroleum is any petroleum delivered to Carrier from the Endicott Pipeline. Northstar Petroleum is any petroleum delivered to Carrier from the Northstar Oil Pipeline.

Note 2: Supplemental Ad Valorem Tax Surcharge. In accordance with the settlement approved by the Commission in *ConocoPhillips Transportation Alaska, Inc.*, 162 FERC ¶ 61,180 (2018), a surcharge of \$0.0037 per barrel will be assessed on all shipments from the origin point to the destination point set forth in the Table of Rates above. This surcharge will be assessed in addition to the applicable transportation rate reflected in the Table of Rates.

The foregoing rates were prepared in part through the use of Pumpability Factors of 1.000.

The rates indicated above are exclusive of any demurrage or other charges shown in ExxonMobil Pipeline Company LLC (EMPCo) F.E.R.C. No. 405.3.0, supplements thereto or successive issues thereof and any amounts that Carrier is required by an applicable law or regulation to collect. No gathering service will be performed by Carrier.
